Applications are accepted on a first-come, first-served basis in the order they are received. There is a \$40 application fee payable by cash or check at the time of application submission. Once your application is submitted, you will be contacted by a Veritas representative to schedule an assessment. Using data from the assessment and academic history, the parents, the teacher, and the administration will work together to make the best grade placement for each child. The final step of the enrollment process is the family interview with a few board members and the headmaster. This is a great opportunity for prospective parents to learn about Veritas policies and ask questions.
